## **CORPORATE MEMBERSHIP**

The maximum number of Corporate Memberships available in a given year will be determined by the Board of Governors and may be amended at any time without notification. 2017 maximum is forty (40) Full Corporate members.

The Company must be registered under the laws of Manitoba or in another province of Canada.

The Company must be approved by the Board of Governors of Elmhurst. Proof of employment or corporate affiliation will be required for each individual or corporate membership.

Includes the use of one locker, shoe cleaning, as well as storage and cleaning for one set of clubs for the **head corporate member**. Additional locker and club storage may be obtained at the cost of \$100 per additional member.

A Food and Beverage Minimum Requirement of \$600.00 per Corporate Membership will be levied. The Requirement will be imposed against the master Corporate Account.

Members and their guests must abide by the rules (including Dress Code policy) of Elmhurst Golf and Country Club.

Signing privileges for the dining facility and/or Pro Shop must be designated at the start of the golf season. A list of corporate signers may be kept in the Dining Room or Pro Shop. **All unpaid balances as of November 15 will be transferred to the head corporate account.**

### **Delinquent Accounts:**

Funds owing that have not been paid within 60 days of the month they incurred will be considered delinquent. Members with delinquent accounts will be issued a service charge of **2% per month** on the amount owing to the club.

Payment of yearly fees is due in full by March 31<sup>st</sup> of the year of membership. Payment for purchases and services are payable on receipt of the monthly statement. The current Elmhurst credit policies apply.

### **There is:**

A one time Initiation Fee of \$2000 (Plus GST) for **Full Unrestricted**

A one time Initiation Fee of \$1000 (Plus GST) for **Half Unrestricted**

No share purchase required.

**No shareholder privileges included with this membership category.** If a current shareholding member wishes to switch to a corporate membership they are required to pay the inactive shareholder fee **OR** give up their share, as well as pay the one time corporate initiation fee.

## Tee Time & Booking Policy

- ❑ Tee times are Unrestricted, with the following caveat: that during prime tee times on **Saturday, Sunday and holidays (meaning prior to 1:00 PM) only one (1) guest per member is permitted.** Guests under the age of 18 may not tee off before 1:00 P.M. on weekends and holidays. Anyone not included on the list of four (4) members constitutes a guest. The Pro Shop will enforce this rule.
- ❑ 10 day advance booking privileges.
- ❑ One of the named employees may bring up to three (3) guests for a round of golf. Corporate Members may use corporate passes for guests or can pay guest green fees. This may be charged in the Pro Shop, paid in cash or charged to a credit card in the Pro Shop.
- ❑ **No more than one foursome per corporate Membership will be allowed on the course at any given time unless approved by club management.**
- ❑ Corporate passes must be used in the season that they are issued.
- ❑ A round of nine or more golf holes played constitutes a round of golf played. There are no partial rounds played.

## **DRESS CODE**

### **GENERAL**

The purpose of these rules is to provide guidance to the Members in matters of dress appropriate to the decorum of the Club. It is the responsibility of every Member, including juniors, to ensure that he or she is fully conversant with and complies with the rules of dress both on and off the Golf Course. Members are likewise responsible for ensuring the dress of their guests is in accordance with the rules. Recognizing that golf styles change, and unless rules specifically prohibit above, discretion in such matters of dress as fabrics, collars, sleeves and hem length is left to the Club Management. In the exercise of that discretion, Club Management shall ensure that in every instance, the dress of a Member or guest is clean, neat tasteful and in keeping with the decorum appropriate to a private club such as Elmhurst.

### ***PROHIBITED DRESS***

Blue jeans and blue denim outfits, cut-offs, tank tops, muscle shirts, short shorts, track suits are not permitted anywhere on Club property without the express permission of the Board of Governors. Tracksuits, T-shirts, sweat suits of any kind may under no circumstances be worn in the dining areas of the Club, on the Grounds or on the Golf Course. Clothing displaying large commercial logos (football/hockey/baseball or similar jerseys), except those that are golf related, is not permitted. Caps shall be worn on the Golf Course with the peak facing forward. Golf hats or caps may not be worn in the dining areas except on the upper veranda.

**Women's** Golf Shirts, with collar or sleeves, slacks, pants, shorts with pockets sewn closely to garment, sweaters, jackets, skirts and rain wear. Shorts, skirts, and skorts must be conservative length being no shorter than mid thigh. Golf shirts must be worn inside the waist unless tailored to be untucked.

**Men's** Golf shirts shall have sleeves and collars. Slacks, pants, shorts with pockets sewn closely to garment, sweaters jackets and rain wear are permitted. Shirts are to be tucked in at the waist unless they are tailored to be untucked as defined by- hemmed, evenly cut around the bottom a reasonably conservative length below the belt.

***Soft spike, spikeless shoes or sandals must be worn at all times. Golf shoes are preferred, but light tread running shoes are acceptable.***

### ***THE DINING ROOM***

The Elmhurst dress code will be enforced in the dining room as it will be in the member lounge. Business casual dress is preferred. Shorts will not be permitted in the dining room. It is expected that members that bring guests to functions such as Sunday and Holiday brunches assure that their guests are dressed appropriately.

**Members or guests who are not in compliance with the rules of dress may be asked to change into dress more appropriate or, failing to do so, to leave Club premises at the discretion of Elmhurst Club Management.**
