General Information

- A share is required for all Membership categories beyond 40 years of age. The cost of a share for active members is \$2000 (plus GST).
- Shares may be transferred to family members as a one-time option, upon written request. Share redemption is available but not on demand. A waiting list shall occur if there are more requests for share redemption than shares being purchased.
- If a Shareholder does not advise, in writing or by email, their desire to switch membership categories, they will automatically be enrolled in the previous year's category.
- A time payment plan is available for membership dues for all members except those in the Corporate, Affiliate and Junior. Please see "Time Payment Arrangement for Membership Dues".
- Payment of share can be included in monthly payment plan.
- Current members MUST advise the Club Secretary or Director of Golf, in writing or email, prior to March 15th, 2017 if they intend to not renew their membership or they will be held liable for payment of annual dues.
- Proof of age may be required for membership in age category groups.
- All 2017 dues included in this package do NOT include GST unless otherwise indicated.
- **2017 Membership Promotions**
 - New shareholders receive \$1000 off 2017 dues with a share purchased in full.
 - Potential new members over age 70 may join without a share purchase.
- Refund requests for Membership suspensions due to ill health shall be in accordance with the existing Medical Refund Policy.

PLEASE NOTE: The Dress Code policy is in effect for all members of Elmhurst Golf & Country Club, as well as their guests.



Membership Benefits for 2017

- **ELMHURST MEMBER PREFERRED PRO SHOP PRICING** – Members receive preferred pricing on all stock items as well as special orders. Members can purchase all pro shop items for landed cost plus 10%.
(*Please note* Corporate and tournament orders are subject to a modified pricing structure.)
- Juniors (aged 18 or under) of Unrestricted Shareholders offered membership at no charge. Grandchildren at 50% off the Junior Rate.
- Intermediate Members of Unrestricted Shareholders receive 50% off memberships if enrolled in post-secondary education or \$200 off Intermediate rate if a non-student, up to age 25.
- Season-long Cart Membership (single rider) for \$750 including tax.
- Spousal package of 12 restricted time green fees for \$600 plus GST. This package does not include account signing privileges, club storage, locker, use of practice facility or use of the handicap system. This add on package is limited to one per spouse.
- **NEW** Intermediate Membership Structure
 - 4 categories from ages 19-40
 - Intermediate A (ages 31-40) - \$2400 Unrestricted
 - Intermediate B (ages 31-40) - \$2000 Restricted
 - Intermediate C (ages 19-30) - \$1750 Unrestricted
 - Intermediate D (ages 19-30) - \$1350 Restricted
 - A student discount of \$200 will apply if enrolled in post-secondary education.
 - For every consecutive year enrolled in the Intermediate category, members will receive a \$200 credit towards their share purchase.
 - A \$200 discount on dues for Intermediate Members who currently own a share.
- Active Shareholders age 75 and over can donate their share to the club and receive \$500 per year off dues for the next 4 years. Please call the administration office for more details at 204-224-2244.

NOTES REGARDING MEMBERSHIP PAYMENT & ACCOUNTS

Early Bird Payment Plan:

Pay your dues in full by January 31, 2017 and receive 2 free guest passes for 2017.
(With the exception Affiliate, Intermediate and Junior.)

If not enrolling in Payment Plan, all membership dues are payable in **full** by **March 31, 2017**. All dues paid after this date will be subject to a \$50 late fee.

All dues must be paid in **full** or member **must be enrolled in Elmhurst Payment Plan** to be eligible to golf at the beginning of the season.

Delinquent Accounts:

Funds owing that have not been paid within 60 days of the month they incurred will be considered delinquent. Members with delinquent accounts will be issued a service charge of **2% per month** on the amount owing to the club.

DRESS CODE

GENERAL

The purpose of these rules is to provide guidance to the Members in matters of dress appropriate to the decorum of the Club. It is the responsibility of every Member, including juniors, to ensure that he or she is fully conversant with and complies with the rules of dress both on and off the Golf Course. Members are likewise responsible for ensuring the dress of their guests is in accordance with the rules. Recognizing that golf styles change, and unless rules specifically prohibit above, discretion in such matters of dress as fabrics, collars, sleeves and hem length is left to the Club Management. In the exercise of that discretion, Club Management shall ensure that in every instance, the dress of a Member or guest is clean, neat tasteful and in keeping with the decorum appropriate to a private club such as Elmhurst.

PROHIBITED DRESS

Blue jeans and blue denim outfits, cut-offs, tank tops, muscle shirts, short shorts, track suits are not permitted anywhere on Club property without the express permission of the Board of Governors. Tracksuits, T-shirts, sweat suits of any kind may under no circumstances be worn in the dining areas of the Club, on the Grounds or on the Golf Course. Clothing displaying large commercial logos (football/hockey/baseball or similar jerseys), except those that are golf related, is not permitted. Caps shall be worn on the Golf Course with the peak facing forward. Golf hats or caps may not be worn in the dining areas except on the upper veranda.

Women: golf shirts, with collar or sleeves, slacks, pants, shorts with pockets sewn closely to garment, sweaters, jackets, skirts and rain wear. Shorts, skirts, and skorts must be conservative length being no shorter than mid thigh. Golf shirts must be worn inside the waist unless tailored to be un-tucked.

Men: Golf shirts shall have sleeves and collars. Slacks, pants, shorts with pockets sewn closely to garment, sweaters jackets and rainwear are permitted. Shirts are to be tucked in at the waist unless they are tailored to be un-tucked as defined by: hemmed, evenly cut around the bottom a reasonably conservative length below the belt. Cargo shorts are not considered to be appropriate golf attire. Any shorts with baggy pockets are strictly prohibited.

Soft spike, spike less shoes or sandals must be worn at all times. Golf shoes are preferred, but light tread running shoes are acceptable. Shoes with metal or ceramic penetrating spikes are prohibited on the Golf Course or the Practice Facilities.

THE DINING ROOM

The Elmhurst dress code will be enforced in the dining room, as it will be in the member lounge. Business casual dress is preferred. Shorts will not be permitted in the dining room. It is expected that members that bring guests to functions such as Sunday and Holiday brunches assure that their guests are dressed appropriately.

Members or guests who are not in compliance with the rules of dress may be asked to change into dress more appropriate or, failing to do so, to leave club premises at the discretion of Elmhurst Club Management.
