## CORPORATE GOLF MEMBERSHIPS

A Corporate Golf membership at Elmhurst Golf & Country Club provides an exceptional opportunity to enhance your company's networking, staff appreciation and entertainment ability.

The company applying must be a registered business under the laws of Manitoba or another province of Canada.

The company must be approved by the Board of Governors of Elmhurst. Proof of employment or corporate affiliation will be required for each individual on the corporate membership.

All Corporate Golf Memberships are available on a limited basis. A maximum of 15 Unrestricted Corporate Membership Groups and no more than 40 total Corporate Membership groups shall be allowed as per Elmhurst Golf & Country Club by-laws.

### Membership Benefits Include:

#### Elmhurst Member Pro Shop Pricing

Members receive preferred pricing on all stock items as well as special orders. Members can purchase all pro shop at a discount over other golf shops. Profits from the shop go directly back to Elmhurst members. (**\*Please note\*** Corporate and tournament orders are subject to a modified pricing structure.)

#### Advance Tee Time Booking

Unrestricted Corporate members are able to book tee times 7 days in advance. **No lottery system.** Know your tee time and be able to plan.

#### Access to Elmhurst Events

Corporate members may play in and attend all Elmhurst member events.  
(subject to additional cost & field size)

#### PGA Golf Clinics & Lessons

Have the ability to book individual lessons or corporate golf clinics with award-winning PGA of Canada professionals.

#### No share purchase is required; however Corporate Membership Groups are subject to:

A one time Initiation Fee of \$2000 (plus GST) for **Full Corporate Membership Groups**

A one time Initiation Fee of \$1000 (plus GST) for **Half Corporate Membership Groups**

**No shareholder privileges are included.** If a current shareholding member wishes to switch to a corporate membership they are required to pay the inactive shareholder fee **OR** give up their share, as well as pay the one time corporate initiation fee.

Corporate membership Include the use of one locker, shoe cleaning, as well as storage and cleaning for one set of clubs for the selected member. Additional lockers and club storage may be obtained at a cost of \$100 per member.

## **MEMBERSHIP DETAILS**

### **Member Golf Event Priveleges/Restrictions:**

Corporate Members may play in member golf events at additional cost to the standard entry fee. Access to events with limited field sizes will not be guaranteed as entry priority is given to Shareholder Members, Intermediate Members, followed by Corporate Members.

### **Practice Facility Use:**

All Corporate Memberships include unlimited use of the driving range & short game area.

### **Lockers & Club Storage:**

Corporate Members will be assigned one locker & one club storage space per membership group. Additional lockers & storage spaces will be charged at \$100 per person.

### **Food and Beverage Assessment:**

\$600.00 per membership will be assessed to the main corporate account.

### **Capital Improvement Fund Assessment:**

\$75 per member will be charged as a Capital Improvement Fund assessment.

### **Account Signing Priveleges:**

Signing privileges for the on the golf course, lounge and Pro Shop must be designated at the start of the golf season. **All unpaid balances as of October 31<sup>st</sup> will be transferred & charged to the head corporate account.** Payment of yearly fees is **due in full by March 31<sup>st</sup>** of the year of membership. Payment for purchases and services are payable on receipt of the monthly statement. The current Elmhurst credit policies apply.

### **Delinquent Accounts:**

Funds owing that have not been paid within 60 days of the month they incurred will be considered delinquent. Members with delinquent accounts will be issued a service charge of **2% per month** on the amount owing to the club.



## TEE TIMES & GUEST POLICIES

- 7 day advanced booking for Corporate Members (unrestricted & restricted)
- Corporate Members may use part of their round allotment for guests, or guests may pay separately.
- Tee times booked may be booked using the following guidelines:
  - At least one Member must accompany a group on the golf course.
  - Prior to 12:00 noon on **Saturdays, Sundays and holidays only one (1) guest per member is permitted.**
  - Guests under the age of 18 may not tee off before 1:00 P.M. on weekends and holidays.
  - Anyone not included on the list of four (4) Members constitutes a guest.
  - The Pro Shop will enforce these rule with no exceptions.
- Corporate Members may use corporate passes for guests or can pay guest green fees. This may be charged in the Pro Shop, paid in cash or charged to a credit card in the Pro Shop.
- **No more than one foursome per corporate Membership will be allowed on the course at any given time unless approved by club management.**
- No fivesomes will be allowed without approval of club management.
- Dress code for both the golf course, and clubhouse will be strictly enforced. Any Member or guest deemed to be not adhering to the dress code will be asked to change or leave the premisis with no exceptions.

**Guests may play up to a maximum five (5) times in one season. This rule is strictly enforced.**



## **DRESS CODE POLICY**

### **GENERAL**

It is the responsibility of each member, regardless of category, to ensure that both they and their guests are fully aware of and compliant with the rules of dress both on and off the golf course.

Suitable dress is required on Elmhurst premises at all times. Club management will ensure that in every instance, the dress of a member or guest is clean, neat, and tasteful. Recognizing that golf styles change, and unless the dress code specifically prohibit the clothing, discretion in such matters of clothing such as fabrics, collars, sleeves and hem length is left to Club Management.

### **ACCEPTABLE GOLF COURSE DRESS**

The following standard of dress applies for the golf course and practice facility:

#### **For women:**

Shirts with a collar or sleeves, slacks, pants, shorts with pockets sewn closely to garment, sweaters, jackets, skirts and rainwear.

Shorts, skirts, and skorts must be conservative in length being no shorter than mid thigh.

#### **For men:**

Shirts with sleeves and collars. Slacks, pants, shorts with pockets sewn closely to garment. Sweaters, jackets and rainwear are permitted. Shirts are to be tucked in at the waist unless they are tailored to be un-tucked as defined by being: hemmed, evenly cut around the bottom, and a reasonably conservative length below the belt.

#### **Footwear:**

Soft-spike, spikeless shoes, or golf sandals must be worn at all times on the golf course or practice facilities. Golf shoes are preferred, but light tread running shoes are acceptable.

Dress shoes or shoes with rugged or studded soles or heels are not permitted on the golf course.

#### **Headwear:**

**For men and women:** Hats on the golf course must have the peak facing forward.

### **PROHIBITED GOLF COURSE DRESS**

Denim pants or jackets, t-shirts, cut-offs, tank tops, muscle shirts, short shorts, track suits are not permitted anywhere on the golf course or driving range.

Cargo shorts with loosely sewn pockets are not considered to be appropriate golf attire. Any shorts with baggy pockets are strictly prohibited.

Clothing displaying large commercial logos, such as hoodies and jerseys, except those that are golf related, are not permitted on the golf course or in the clubhouse.

### **INDOOR DINING AREA DRESS**

The same dress code policy will be enforced in the indoor dining areas of Elmhurst with the following exceptions:

#### **Denim:**

**Business casual denim** in good repair, without any rips, frayed ends or holes is permitted in the clubhouse and lounge areas at any time. Business casual dress (no denim) is preferred for the dining room.

#### **Headwear:**

Men may not wear hats in or around any of the indoor dining areas. Women are permitted to wear hats.

***Members or guests who are not in compliance with the rules of dress may be asked to change into dress more appropriate or, failing to do so, to leave Club premises at the discretion of Elmhurst Club Management.***
