



# 2021 Membership Information



## GENERAL INFORMATION

- A share is required for all Membership categories beyond 40 years of age. The cost of a share for active members is \$2000 (plus GST).
- Shares may be transferred to family members as a one-time option, upon written request. Share redemption is available but not on demand. A waiting list for redemption is in place that will see a share on the list be redeemed as a new share is sold.
- If a **current member** does not advise, in writing or by email by December 1<sup>st</sup>, a desire to switch membership categories, they will automatically be enrolled in the previous year's category.
- A time payment plan is available for membership dues for all members except those in the Corporate, Affiliate and Junior. Please see "Time Payment Arrangement for Membership Dues".
- Payment of share can be included in monthly payment plan.
- **Current members** must advise Club Secretary or Director of Golf in writing or email, **prior to March 15<sup>th</sup> 2021** if they do not intend to renew their membership or they **will be held liable for payment of annual dues**.
- Proof of age required for membership in age category groups.
- All 2021 dues included in this package do not include GST unless otherwise indicated.
- Refund requests for Membership suspensions due to health issues shall be in accordance with the existing Medical Refund Policy.

## 2021 MEMBERSHIP PROMOTIONS

- New shareholders receive \$1000 off 2021 and 2022 dues with a share purchase.
- Juniors of Unrestricted Shareholders may join at zero charge.
- New members over age 70 may join without a share purchase.
- Intermediate Spouses may join at 25% off the Intermediate Member rate.
- Female spouses of Shareholders & Intermediates may join the 10 week Ladies Nine & Wine night at \$200 for the season.
- Early Bird Payment: Dues paid in full by January 31 will receive 2 free guest passes for 2021. (With the exception Affiliate, Intermediate and Junior.)



## 2021 MEMBERSHIP BENEFITS

- Unrestricted Shareholders receive 10 day advance booking privileges and priority access to member golf events where field size may be limited.
- Juniors (aged 18 or under) of Unrestricted Shareholders offered membership at no charge. Grandchildren at Junior rate of \$275. Juniors of Unrestricted Shareholders may sponsor their friends to join for \$375 for the season.
- Spouses of Shareholders may play golf with their spouse an unlimited amount at applicable guest golf rates.  
Weekend & Holiday spousal rates available after 3pm.
- Female spouses of Shareholders & Intermediate members may join the Ladies Nine & Wine Night for \$200 for the season. Details of the Nine and Wine may be found in the Member Golf Events program released at the start of the golf season.
- Payment of shareholder membership dues by cheque or debit card will receive a 2% discount.
- Season-long Cart Memberships (single rider) for \$750 plus tax.
- Active Shareholders age 75 and over can donate their share to the club and receive \$500 per year off dues for the next 4 years.

- Intermediate Membership Benefits
  - Unrestricted and Restricted categories for ages 19-30 and 31-40.
  - Spouses of Intermediate Members can join at 25% off the Intermediate rate.
  - A student discount of \$200 will apply if enrolled in post-secondary education under age 25.
  - For every consecutive year enrolled in the Intermediate category, Members will receive a \$200 credit towards their share purchase.
  - A \$200 discount on dues applies to Intermediate Members who currently own a share.
  - Intermediate Members who have parents that are Unrestricted Shareholders receive 50% off memberships if enrolled in post-secondary education or \$200 off Intermediate rate if a non-student, up to age 25.
  - Intermediate Members with a share paid in full receive Unrestricted Shareholder privileges if in the Unrestricted Intermediate category.
- ELMHURST MEMBER PRO SHOP PRICING – All members receive preferred pricing in the member-owned Pro Shop. Clubs, Bags & Shoes at 5% off regular retail price, Apparel and Accessories at 20% off regular retail price plus any applicable shipping charges on special orders.

### Food & Beverage Assessments for 2021 are as follows:

### Capital Improvement Fund Assessment:

All Shareholders will be issued a \$250 Capital Improvement Fund assessment on their May 2021 statement. Intermediate members in the 31-40 category will be issued a \$75 assessment.



## MEMBERSHIP DUES PAYMENT & ACCOUNTS

**Payment of shareholder membership dues by cheque or debit card will receive a 2% discount.**

### **Membership Dues Payment:**

Membership dues must be paid in full, or dues payment plan arrangements made by **March 31, 2021**. All dues paid after this date will be subject to a \$50 late fee.

All dues must be paid in **full** or member must be enrolled in the **Twelve-Month Payment Plan (see next page)** to be eligible to golf at the beginning of the season.

### **Early Bird Payment:**

Dues paid in full by January 31 will receive 2 free guest passes for 2021.  
(With the exception Affiliate, Intermediate and Junior.)

### **Delinquent Accounts:**

Funds owing that have not been paid within 60 days of the month they incurred will be considered delinquent. Members with delinquent accounts will be issued a service charge of **2% per month** on the amount owing to the club.

Any delinquent account balance will make member ineligible to use club facilities until paid.



## TWELVE MONTH PAYMENT PLAN

(ALL PRICES INCLUDE TAX)

By enrolling in the payment plan, members have the option of spreading their dues out across the calendar year. The **2021 twelve month Payment Plan begins November 25, 2021.**

Share payment can be combined as part of the 12-month payment plan.

### SHARE AGREEMENT NOTES (WHERE APPLICABLE)

Please review the following notes as it pertains to a share purchase of Elmhurst Golf & Country Club. Signature on Membership Acceptance Agreements constitutes acknowledgement of the terms outlined below.

- A full share of Elmhurst Golf & Country Club is deemed to be worth \$2000.
- Shareholders must remain, **at minimum**, in the Inactive House category to be considered in good standing. Otherwise the Shareholder must divest themselves of said share.
- Shareholders choosing to move to a corporate category are responsible to pay the Inactive share fee or else divest themselves of said share.
- Once purchased, a Shareholder may only divest themselves of said share in the following ways:
  - 1) Transfer of share to a direct family member.
  - 2) Apply to be placed on the share redemption list. In which case the share will be paid back in full at such time that the outgoing Shareholder's name reaches the top of the list. The Elmhurst office will provide updates on the list when requested.
  - 3) Sell the share privately. In order to do so, the share must be paid up to the full \$2000 value.
